



ARTICLES OF INCORPORATION OF

The undersigned incorporator or incorporators, desiring to form a corporation (hereinafter referred to as the "Corporation") pursuant to the provisions of the Indiana Not-For-Profit Corporation Act of 1971, (hereinafter referred to as the "Act"), execute the following Articles of Incorporation:

ARTICLE I Name

The name of the Corporation is . Elkhart County Radio Association, Inc. (The name shall include the word "Corporation" or "Incorporated", or one of the abbreviations thereof.)

ARTICLE II Purposes

The purposes for which the Corporation is formed are:

To establish and maintain one or more amateur radio "repeating" stations; to promote and facilitate amateur radio communications; and for any and all other purposes consistent with law.

NOTE: "Not-for-Profit" as applied to corporations means, "... any corporation which does not engage in any activities for the profit of its members and which is organized and conducts its affairs for the purposes other than the pecuniary gain of its members". (Indiana Code, 23-7-1.1-2[d])

ARTICLE III Period of Existence

Section 3. Voting Rights of Classes: All members have equal voting rights. Voting by proxy is disallowed, though the bylaws may provide for "absentee" voting.
